- ▶ **Three part-time or seasonal employees equal one full-time employee.**
- ▶ Real estate, brokerage and insurance firm agents and independent contractors are counted as employees.
- ▶ All Member Businesses and Organizations have the ability to be listed in additional categories in the printed directory and website for a \$25 fee per category.
- ▶ Members with significant ownership in multiple businesses could be eligible for a special membership rate.
- ▶ New Members that sign up after March 31st are eligible for a prorated amount in their second year.
